Public information materials and exhibition display materials

The review and refresh of the public information materials and exhibition display materials has now been completed. Feedback from the Plain English Campaign and Connect, a disability communications organisation, has enabled us to refresh the design, content, format and layout of the public information materials to ensure they are update and accessible to members of the public. The leaflet is now crystal marked and includes practitioner psychologists. We will review the materials again when we add hearing aid dispensers in March 2010. The dissemination of the public information materials has been included in the media and campaigns update report for Committee.

Issues Brief

A weekly email which provides the Executive with a summary of news and issues relevant to the activities of our external stakeholders has been launched. Areas covered include Department of Health consultations or reports, parliamentary questions or debates and news from other regulators and professional bodies.

We also report on significant media coverage of the HPC and include key and external meeting dates.

Requests / distribution of publications and materials

Between May and October publications were sent to 26 separate events, which included exhibitions, conferences, parliamentary conferences and HPC listening events. Though the number of delegates at these events varied, as did the number of documents dispensed, specific publications proved popular to attendees. These included: CPD long guides, SCPEs, samples of SOP's, SET's, FtP Annual Reports for 2008 and 2009, Grandparenting reports, FtP complaint booklets, FtP process booklets, Returners to practise guidance, Confidentiality guidance, public information materials, renewal posters and Be healthwise campaign materials.

Of our most popular publications we gave out approximately 4,000 CPD long guides, 6,500 SCPE, 1,100 FtP annual reports.

The delivery of our HPC public information materials has now been outsourced and between the months of May and October we have sent out the following numbers of public information packs. A pack consists of one renewal poster, two public information posters and approximately 25 leaflets.
